Members socialize and network locally, nationally and internationally with people working in many different fields. In order to accomplish our goals, Zontians participate actively in committees and meetings.

**Meetings:** Zonta Club of Findlay meets at noon on the 1<sup>st</sup> and 3<sup>rd</sup> Tuesdays of each month. The 1<sup>st</sup> meeting is the Club business meeting. Meetings held on the 3<sup>rd</sup> Tuesday of each month feature entertaining and educational programs. In addition, committees hold meetings at their discretion to accomplish their designated tasks. Throughout the year we have fellowship opportunities and fun outings.

**Fundraising:** In order to accomplish the goals of Zonta locally we participate in 2 major fundraisers per year. We have a Nut & Candy sale in the fall and we sell Germaniums in the spring.

**Philanthropy:** Zontians have many opportunities to serve our community and elsewhere both nationally and internationally. We contribute time, support and/or funds to Habitat for Humanity, City Mission, Hope House, Open Arms, packaging birthing kits for third world countries, etc. Our geranium sales allow us to give scholarships to local woman to further their education.

**Initial Dues:** Initial dues are due either November 30<sup>th</sup> (\$70.50) for ½ a year or May 31<sup>st</sup> (\$130) for full year plus a one-time initiation fee of \$35. Subsequent dues of \$130 are due May 31<sup>st</sup>.
